The Minnesota State University Moorhead (MSUM) nursing programs utilize evidence-based, holistic care concepts to help persons set goals for optimal wellbeing of body-mind-spirit, with high regard for diversity. We believe that this whole health approach serves as a catalyst for relationship-based, person-centered nursing and education. We believe:

- Nurses holistically care for the person, which includes individuals, families, societal groups, communities, and populations. Each person is unique and multidimensional, interacting with self and the environment in dynamic relationships. Nursing supports each person in pursuit of their desired state of health and overall wellbeing.
- Health is an ever-evolving state encompassing physical, mental, social, and/or spiritual wellbeing
  and functioning across the continuum of life. As nurses, we strive to assist clients to achieve a
  higher level of health that is consistent with their belief & value system. In addition, the pursuit of
  wellbeing is the right and responsibility of each person and is to be respected and supported.
- The environment encompasses the internal and external circumstances and surroundings of the person. These include real and perceived physiological, psychological, cultural, spiritual, economic, social, and technological influences. We believe that the person is in constant interaction with the environment and that nurses are a vital part of this environment.
- The profession of nursing is both an art and a science, which serves to protect, promote, and optimize health and ability, prevent illness and injury, facilitate healing, and alleviate suffering (American Nurses Association, 2017).

MSUM nursing faculty and students synergistically provide an innovative curriculum ensuring "real world" experiences to challenge adult learners. Students expand their knowledge through individual and interprofessional collaborative experiences through progressive use of advanced teaching methodologies. Our embraced teaching/learning process fosters intellectual and personal growth; stimulates inquiry, critical thinking, and synthesis of knowledge; and helps the individual value and pursue life-long learning. We advocate for professional career and degree advancement tailored to the unique needs of each person. We connect with students as colleagues and assume the role of facilitator of learning. We foster relationships that are caring, nurturing, guiding, and supportive while maintaining high expectations, applying evidence-based concepts, ensuring quality education, and upholding integrity. ### **Graduate Nursing Application of the SNHL Nursing Philosophy**

The philosophy of the SNHL Nursing Program embodies a set of beliefs that provide the context in which the mission is realized. As a discipline, nursing encompasses the components of nursing science, the art of nursing, personal knowledge, and ethics. The discipline continues to evolve from the interrelationships among nursing theory, research, and practice. This evolution involves an expanding body of nursing knowledge that blends with the arts, sciences, and humanities to form a framework for nursing practice.

Through the graduate nursing program, the nurse is prepared to perform multiple roles in diverse settings and is responsive to the changing health care needs of society. The nurse is accountable and responsible for actions taken within these roles. We believe that:

- Professional nurses participate in activities that contribute to the ongoing development of the body of knowledge of the nursing discipline.
- Learning is a process evidenced by changes in cognitive, affective, and psychomotor behavior.
   Student learning is best facilitated in an environment of acceptance and freedom of expression that fosters critical thinking, self-understanding, caring, and creativity. Faculty provide opportunities for learning through experiences designed to integrate theory with practice,

- promote a spirit of inquiry, and model/provide opportunities for students to develop critical thinking abilities. Preparation of professional nurses is achieved through collaborative partnerships in which both the teacher and learner are actively involved and accountable.
- Caring, integral to professional nursing practice, encompasses the nurse's empathy for and connection with the client. Caring is demonstrated in compassionate, sensitive, and appropriate nursing care that preserves human dignity and nurtures the human spirit.

# **Graduate Nursing Program Overview**

The graduate nursing program offers master's level preparation in one of two emphases: (a) Nurse Educator and (b) Nursing Administration and Organizational Systems Leadership. Post-baccalaureate certificates are available in: (a) Nurse Educator and (b) Nursing Administration and Organizational Systems Leadership, and (c) Informatics, Evidence-based Practice, and Project Management/Strategy.

The master's curricula includes graduate nursing core courses, emphasis-specific courses, and clinical practica. A culminating professional portfolio is required for those seeking a MS degree. Students collaborate with their advisors to select practica that fit their areas or populations of interest. Clinical practica may take place in the student's home area, if appropriate.

### Accreditation

The master's degree in nursing at Minnesota State University Moorhead is accredited by the Commission on Collegiate Nursing Education (CCNE) (<a href="http://www.ccneaccreditation.org">http://www.ccneaccreditation.org</a>). MSUM is accredited by the Higher Learning commission of the North Central Association of Colleges and Schools at the Master's degree level.

# **NAOSL Program Description and Student Learning Goals**

The Nursing Administration and Organizational Systems Leadership (NAOSL) program prepares early career and current nurse leaders for graduate level nursing and healthcare leadership. Advanced education in nursing administration and organizational systems leadership addresses the growing need for system-wide leadership within the healthcare industry. The program emphasizes increased depth of understanding of the complex systems and issues involved. Graduate outcomes are based upon the American Association of Colleges of Nursing Master's Essentials and incorporates the competencies put forth by the American Organization for Nursing Leadership (AONL), American Association of Critical-Care Nurses, and Essentials of Nurse Manager Orientation.

In addition to the Master of Science with Major in Nursing Program core Program Student Outcomes (PSOs), upon completion of the Nursing Administration and Organizational Systems Leadership Emphasis, graduates are expected to:

The Nursing Administration and Organizational Systems Leadership (NAOSL) Post-Baccalaureate Graduate Certificate prepares early career and current nurse leaders in the areas of nursing and healthcare leadership. The certificate program emphasizes the key areas of leadership essential to successfully navigating complex healthcare systems while in a leadership role. Credits earned can be applied toward the Master of Science with Major in Nursing, NAOSL Emphasis for students who would like to earn a graduate degree.

Upon completion of the Nursing Administration and Organizational Systems Leadership post-baccalaureate certificate program, graduates are expected to:

- NAOSLC1: Incorporate theoretical contributions and scientific knowledge of the discipline into nursing practice, nursing administration, and nursing leadership.
- NAOSLC2: Collaborate in scholarly activities of inquiry related nursing practice, nursing administration, and nursing leadership.
- NAOSLC3: Contribute to the improvement of health policy, delivery of health services, and the financing of health care.
- NAOSLC4: Demonstrate competency in the specialized role of nurse administrator and/or leader within the context of independent and collaborative nursing practice.

# Nurse Educator Emphasis-Specific Program Description and Student Learning Outcomes

The Nurse Educator (NED) emphasis prepares registered nurses holding a Baccalaureate Degree in Nursing at the Master of Science level in nursing education within academic and clinical arenas. The emphasis is built upon the art and science of nursing education within the changing contexts of health care, nursing, higher education, and evidence-based practice. Within the broader Graduate Nursing program outcomes, the NED emphasis adapts to provide students with understanding and evidence-based application of the faculty role; teaching-learning processes; curriculum development, management and evaluation; program and student evaluation; and modalities to accomplish education within the various settings. Students receive experiential practica in academic and healthcare settings. Didactic work is delivered in an online format. The curriculum is based upon the American Association of Colleges of Nursing Master's Essentials and the National League for Nursing Certified Nurse Educator (CNE) competencies.

In addition to the Master of Science with Major in Nursing Program core Program Student Outcomes (PSOs), upon completion of the Nurse Educator Emphasis, graduates are also expected to:

- NED Goal A: Facilitate learning using theories of education, best evidence, technological innovation, and reflective practice (NLN NED Competency I; MS PSO 1, 2, 4, 5, 8, 9).

The Nurse Educator (NED) Post-Baccalaureate Graduate Certificate prepares registered nurses holding a Baccalaureate Degree in Nursing at the certificate level in nursing education within the academic and clinical arenas. The certificate is built upon the art and science of nursing education within the changing contexts of health care, nursing, higher education, and evidence-based practice. The certificate provides students with a basic understanding and evidence-based application of the nurse educator role. Credits earned can be applied toward the Master of Science with Major in Nursing, NED Emphasis for students who would like to earn a graduate degree.

Upon completion of the Nurse Educator Certificate, graduates are expected to:

- NEC1: Incorporate theoretical contributions and scientific knowledge of the discipline into nursing practice and education.
- NEC2: Collaborate in scholarly activities of inquiry related to nursing practice and education.
- NEC3: Develop, implement, and modify programs or plans of care for diverse client populations.
- NEC4: Demonstrate competency in the specialized role of nurse educator within the context of independent and collaborative nursing practice.

# **IEPMS Post-Baccalaureate Graduate Certificate Description and Outcomes**

The Informatics, Evidence-Based Practice, and Project Management/Strategy (IEPMS) Post-Baccalaureate Graduate Certificate prepares students to implement and lead healthcare practice projects in a strategic manner using quality indicators, dashboards, informatics-based data, national guidelines, and other forms of evidence. Credits earned can be applied toward the Master of Science with Major in Nursing or Master of Healthcare Administration for students who would like to earn a master's degree.

Upon completion of the Informatics, Evidence-Based Practice, and Project Management/Strategy (IEPMS) post-baccalaureate graduate certificate program, graduates are expected to:

IEPMS C1: Analyze current/emerging patient care, informatics, and communication technologies to deliver and enhance healthcare outcomes.

IEPMS C2: Apply safety and quality principles, methods, performance measures, and standards to transparently improve healthcare outcomes across the continuum of care.

IEPMS C3: Integrate research, evidence, theory, clinical reasoning, and patient values to positively impact patient and population healthcare outcomes.

# Interprofessional Courses

Students will be enrolled in courses with other disciplines/professions to promote interdisciplinary collaboration (see course progression plans).

### **Oral Examination Process**

The oral examination process gives the MS degree candidate the opportunity to present the findings of their self-reflection in the Professional Portfolio, demonstrate mastery of the Program Student Outcomes of their plan of study and readiness for specialty role in nursing, and demonstrate alignment of academic accomplishments with emphasis-specific goals.

- To schedule the oral examination, a student must be enrolled in or have completed at least 75% of the total credits required for the degree.
- The oral examination follows the completion of and precedes the acceptance/approval of the culminating scholarly work (portfolio).
- The examination is conducted by the student's Examining Committee.
- The examination is approximately 60 minutes in length.
- The committee then decides if the student's written work is accepted with or without revision and if the student passes or fails the examination. Please refer to the Graduate Nursing Program Oral Examination Evaluation Rubric.
  - Failure on the examination signifies a failure to proceed in the degree candidacy process.
     A student may repeat the examination only by appealing to the School of Nursing and Healthcare Leadership.
- The committee completes the paperwork necessary for the student to proceed in the degree candidacy process or notifies the appropriate office of the student's failure.



# **Significant Infectious Diseases**

Student contact with clients in the health care setting is accompanied by risk of exposure to communicable diseases as well as responsibility to avoid spreading communicable diseases.

If exposed to body fluids:

- Wash the exposed area (not eyes) immediately and thoroughly with soap and water. Cover with a dry sterile dressing if an open wound is present.
- Notify the nursing faculty immediately.
- Seek medical advice immediately from your choice of provider. Students are not covered under workers' compensation; costs of care are the responsibility of the student.
- Complete an incident report (available from the clinical agency); submit one copy to the agency supervisor and one to your clinical faculty.

If you are feeling ill, stay home. Refer to the clinical facility's infectious disease policies.

# Lanyards

Clear identification as a MSUM graduate nursing student is important when representing MSUM in the clinical setting. The nature of the nursing profession requires ethical behavior on the part of students both in the clinical and classroom settings. All work in this program and all related courses must be completed in a manner consistent with MSUM's Academic Honesty Policy (MSUM Student Handbook) and the Graduate Nursing Student Handbook and Policy Manual.

Students are expected to conduct themselves in a professional manner. Nurses are held to an expectation of high integrity and honesty. Therefore, MSUM Graduate Nursing students will be held to the following academic policy:

# **Academic Honesty Expectations**

- Plagiarism and cheating will not be tolerated.
- If a student has questions about the academic policies, it is the student's responsibility to discuss them with the instructor prior to submitting an assignment.
- All required assignments may be subject to instructor submission of the assignment to plagiarism detection software.
- Any student who commits plagiarism as defined by the instructor may fail the paper or the entire course, as determined by the faculty. If the instructor does not define plagiarism, students should use the following definition of plagiarism as a guideline:
  - More than 6 words in a row of exact content from another source without appropriate quotation marks and parenthetical citations.
  - o 10% or more exact cited content throughout the whole paper. This is the core of the paper not including title page, table of contents, reference pages, or appendixes.
  - o 15% or more of very similar content throughout the whole paper. This is the core of the paper not including title page, table of contents, reference pages, or appendixes.
  - Failure to use quotes and parenthetical citations (including author, year, AND page number) when quoting material.
    - Direct quotes should be limited. Please refer to the instructor preferences on this. If not identified by the instructor, it is recommended that students have less than 10% of the entire paper in direct quotes. At the graduate level, students are expected to be able to read scholarly journals and synthesize information in their own words rather than using an excessive number of direct quotes.
- An instructor has the freedom to decide whether to allow the student to resubmit the test, quiz, or assignment for points if the first submission has been found to be plagiarized. The student is expected to learn from the mistakes on subsequent assignments. Subsequent instances of plagiarism in any course puts the student at risk for dismissal from the nursing program and possibly the university.
  - Any student caught copying or cheating on a test, quiz, or assignment, or having same or similar content in a paper to another student (current or former from any course) may fail the test/quiz/assignment or the entire course, as determined by the faculty.

Applicants to the Graduate Nursing Program must meet the following minimum requirements:

Bachelor's degree in nursing from an accredited nursing program.

- Current unencumbered registered nurse (RN) license in the US (does not need to be MN).
- Undergraduate total cumulative local GPA of 3.0 on a 4.0 scale in undergraduate courses at the institution where the baccalaureate nursing degree was awarded; *Provisional admissions are provided on a case-by-case basis for those students that do not meet the minimum GPA*; however, additional application materials may be required.

### Non-Minnesota Applicants:

A student applicant who is not currently a Minnesota resident is not fully admitted until the Department of Higher Education in the applicant's state of residence has approved distance education/online programs from the state of Minnesota. Other state approvals, including, but not limited to, the state's Board of Nursing, must also be in place. Students must check with the Graduate Program Coordinator prior to accepting admission. If the student moves after application to the program, it is the student's responsibility to check with the Graduate Program Coordinator whether continuation in the program is possible in the student's new location.

### **International Students:**

- Student must first meet all the other admission criteria.
- Student must also hold a current Work Visa (not Student Visa) that will be valid throughout the course of study in the graduate program. Only certain types of Work Visas will allow students to take an online program that does not have on-campus requirements. Please refer to the International Student Admission Policies (below\*).
- If student meets criteria 1 and 2, the student must contact the International Student Office at 218-477-2956 to assure eligibility to apply.
- If student is eligible to apply, the student must complete the International Student Application packet wherein the student indicates US citizenship as applicable.

# \*International Student Admission Policy

The Homeland Security Act of 2002 fundamentally changed the requirements for the international students who wish to study in the United States. The major change that affects an online program is that no more than the equivalent of one on-line/distance education class or 3 credits per session may count towards the 'full course of study' requirement. A full copy of the NAFSA (Association of International Educators) Advisory Manual is available in the International Student Affairs office [Chapter 3: F-1 Students; Section 3.20.7; Authority cite 8 C.F.R. SS 214.2(f) (6) (i) (G)]. Students can be admitted to this program if they have an active Work Visa. Students are unable to be admitted to this program if they have a Student Visa.

Portfolio/Project committee members can be selected by students or by department approval.

Portfolio/Project Committee Selection by Students: The student, in consultation with their advisor, selects individuals to serve on the portfolio/project committee. The role of portfolio/project committee members is to supervise the development and completion of the portfolio/project and to conduct the Oral Exam at the completion of the student's program. A committee member should be selected according to the individual's ability to contribute to a successful portfolio/project.

The portfolio/project committee must include two individuals (including the chair).

- Chair
  - Preparation: A MSUM nursing faculty member with a terminal degree (doctorate) in their field from the student's area of study.
  - Graduate Status: Hold Full MSUM Graduate Faculty Status https://www.mnstate.edu/admissions/graduate/faculty-staff/
- Committee Member #1
  - Preparation: A nursing faculty member with a terminal degree (doctorate) OR master's degree in nursing.
  - Graduate Status: Hold Full or Temporary\* MSUM Graduate Faculty Status.
    - \*Temporary Graduate Faculty Status may be granted to a qualified master's or doctorally-prepared individual for the purpose of serving on one specific thesis committee and is limited to the duration of the specific student's enrollment. The Committee Chair must submit the request for Temporary Graduate Status to the Graduate School Dean/Director. Included in this request should be a brief summary of the unique expertise this individual will bring to the committee and the individual's CV. The Graduate Dean will review and decide upon appropriateness of the request.

The School of Nursing and Healthcare Leadership (SNHL) at Minnesota State University Moorhead (MSUM) is committed to providing students with quality internship, practicum and/or capstone projects as defined by their major/program. This policy defines minimum guidelines set forth by MSUM as well as SNHL-specific requirements to prepare, guide, and evaluate those experiences. The Graduate Nursing program requires practicum experiences.

Students work in partnership with faculty, graduate assistants, office assistants, and program coordinators when securing practicum experiences.

#### **General Guidelines**

- MSUM Internship Policy: <a href="https://www.mnstate.edu/policies/">https://www.mnstate.edu/policies/</a>
  - Some of the criteria from the university internship policy may not be applicable to practica required in the Graduate Nursing program.
  - Students will not be required to return to campus after completing an internship/capstone/practicum. Students are expected to complete the remaining courses in their degree program in order to graduate. Students are encouraged to share their experiences with student peers and to complete their program.
- Program Standing:
  - A practicum may be taken only by a student majoring in a program with an approved internship/capstone/practicum component of the curriculum.
  - Graduate students need to have at least a 3.0 GPA and approval to enter into the practicum.
- Credits/Hours
  - A minimum of one (1) semester credit and a maximum of twelve (12) semester credits will be counted toward a degree, dependent upon the specific program curriculum plan.
  - Graduate internship/capstone/practicum credits may be awarded on the basis of fifty (50) hours of fieldwork equates to one semester credit.
- Grading
  - A practicum experience may be graded (by the faculty) on a pass-fail or a grade-basis.
     Refer to course syllabus for course specific grading standards.
- Program Verifications Policy Please see the Program Verification Policy for more information about required verifications (i.e. Background Checks, Vaccinations).
- Interagency Agreement:
  - Before the starting date of the experience, an interagency contract may need to be verified and executed between the site and MSUM that clearly articulates liability assumption, expectations, and responsibilities of Minnesota State University Moorhead, the site, and the student.
  - The current interagency agreement will be kept on file in the SNHL department.
  - Each practicum site will be evaluated for appropriateness by the respective program coordinator or the course faculty.

### **Practicum Procedure:**

- Objectives for practicum are defined in the syllabus of the practicum course (NURS 637P, NURS 642P, NURS 643P, NURS 644P, NURS 645P).
- Interagency Contract: Prior to engaging in any clinical experience, the program will ensure that a current interagency contract exists with the clinical site. If no contract exists, faculty will contact the SNHL office to have an interagency contract initiated.
- Student will refer to the Student Practicum and Preceptor Handbook, found in the practicum course D2L, for more information.
- Methods of Documentation and Assessment:
  - Practicum learning contract
  - o Preceptor agreement
  - Mid-semester preceptor feedback on student
  - Student, preceptor, and faculty beginning-of-semester conference to determine plan and answer questions.
  - Student, preceptor, and faculty mid-semester conference to assess progress and answer questions.
  - End-of-semester preceptor feedback on student
  - Tally of hours
  - Student feedback on practicum preceptor and site
  - There may be additional assessment methods per the faculty's discretion (e.g., papers, presentations, online discussion, and synchronous meeting participation).
- Grading:
  - The practicum is graded by the course faculty using the Graduate Nursing grading scale.
- Monitoring of Practicum:
  - Oversight of the practicum experience is the responsibility of the faculty assigned to the course.
  - Responsibilities of the student, faculty, and the preceptor are outlined in the Practicum Student-Preceptor Handbook.

Minnesota State University Moorhead graduate nursing students engage in diverse practicum experiences during their program of study. Involvement in these practicum experiences may require the student to confirm (and re-confirm) verifications, through the submission of documentation, before their practicum hours start and ensure compliance during their entire practicum experience(s) duration. Program verification requirements are determined by the student's practicum site/agency – please see the general guidelines below.

Students completing practicum at a site/agency that requires:

• An Interagency Affiliation Agreement (full contract) - graduate nursing students <u>do</u> need to submit verification related documentation to the program designated online secure repository and be in compliance with all required site/agency required verifications the semester prior to the practicum semester start. See **Program Verifications** list below.

To remain program compliant, it is the student's responsibility to remain current with verifications listed in the program-designated online repository. Requirements are subject to change, see the online repository for latest requirements). Students who are non-compliant risk practicum course dismissal and this may impact the student's ability to progress in the program.

A Nursing Practicum Information Agreement (short form) or no formal interagency affiliation agreement in place (i.e. MSUM or study abroad) – graduate nursing students may NOT need to submit verification-related documentation to the program designated online secure repository. Please note if the agency requires specific documentation, it will be handled on a case-by-case basis.

Definitions [adapted from Dreyfus (2004) and ACHE (2021)]

- 1 = Novice a beginner, with no experience. Individuals are understanding and gaining information to comprehend skills by using rules obtained in the classroom setting; expected to need help from an expert to understand and apply concepts.
- 2= Advanced Beginner demonstrates acceptable performance, individuals are starting to equate situational and non-situational aspects of learning, along with rules; individuals can start to apply some concepts but are still analytic by following examples.
- 3 = Competent as the individual gains more experience and knowledge, competence develops with solving problems and are involved in forming an outcome. Help from experts might still be required, but usually skills can be performed independently.
- 4 = Proficient- the individual can perceive and understand situations as whole parts. Individuals learn from experiences and knowledge and anticipate what to expect and will react by modifying plans. The individual may consult with an expert but will have a plan developed.

• \*5 = Expert – intuitively, analyzing, recognizing problems with ideas and expertise. The individual relies on progressive experience and wisdom to provide guidance, troubleshoot, and answers questions. They are an expert in that area/field. \*Students are not expected to advance to an expert level in the program, which will come with time and professional experience beyond the scope of the program.

# **Practicum Hour Completion Policy**

Students completing at least 50 of the required 100 clinical hours in NURS 642P, 643P, 644P, or 645P may earn an In-Progress Grade in the course per the guidelines below. In some situations, the student may be encouraged to fully withdraw from the course if the withdrawal deadline has not passed. Note, this is an In-Progress grade (not an incomplete grade). Therefore, an incomplete grade form is not needed (per the registrar 2021). The faculty will enter and In-Progress on the end-of-semester grade entry.

#### Guidelines for an In-Progress grade:

- If there are <10 hours remaining, the student must finish those hours the semester immediately following NURS 642P, 643P, 644P, or 645P (fall, spring, or summer). Completion of those remaining hours should occur within the first four weeks of the following semester. Failure to finish the hours by the timeframe outlined will result in a failure of the 642P/643P/644P/645P course and the NURS 690 course.
- If there are 11-30 hours remaining, the student must enroll in 1 credit of NURS 690 the semester immediately following NURS 642P, 643P, 644P, or 645P (fall, spring, or summer) and finish the hours by the end of that semester. Failure to finish the hours by the timeframe outlined will result in a failure of the 642P/643P/644P/645P course and the NURS 690 course.
- If there are 31-50 hours remaining, the student must enroll in 2 credits of NURS 690 the semester immediately following NURS 642P, 643P, 644P, or 645P (fall, spring, or summer) and finish the hours by the end of that semester. Failure to finish the hours by the timeframe outlined will result in a failure of the 642P/643P/644P/645P course and the NURS 690 course.
- If there are more than 50 hours remaining, the student is not eligible for an in-progress grade. Rather, a failure of the course will be recorded.

In order to maintain enrollment in the program, students must:

- Hold an active and unencumbered RN license from a state within the US. If the clinical practica
  will occur in a state other than Minnesota or North Dakota, the student must have an
  unencumbered RN license in the state where practica will be completed.
- The Department of Higher Education, the Board of Nursing, and possibly other agencies where the student will have their practica must first agree with MSUM offering distance nursing education in the state. It is the student's responsibility to check with the Graduate Program Coordinator whether practica in a state other than MN are possible.
- Remain in compliance with the Graduate Nursing Verifications Policy
- Complete the statistics requirement (see Statistics Requirement Policy).

# Progression and Degree/Graduation Requirements Policy

The following are progression and degree/graduation requirements for a Master of Science in Nursing degree:

- Students must adhere to the <u>MSUM Academic Policies</u>
- If a student steps out of the program for more than one year, when the student re-enters the University, the student will be under the curriculum that is currently in place upon return (not at the time of initial enrollment in the program). Students should work closely with their advisor on the transition.
- Students must complete all program requirements within ten (10) years of admission.
- Student progression is flexible. A maximum of nine graduate semester credits from nursing, all of
  which must be related to the program, may be transferred from other appropriately accredited
  colleges or universities with the graduate nursing program coordinator's consent. The transfer
  credits must be no older than ten years by the time of the MSUM graduate nursing
  program/certificate completion and carry a B or higher grade. Teacher education sequence (TES)
  courses will not be counted as transfer credits to fulfill the graduate nursing program's
  requirements.
- A cumulative GPA of 3.0 is required and must be maintained to continue in and graduate from the program. If the GPA falls below 3.0, the student is placed on probation for the next semester in which courses are taken. If the GPA remains below 3.0 at the end of the next semester, the student will be suspended from the graduate nursing program.
- The graduate school monitors graduate students' GPAs each semester.
- No more than two courses with a grade of C (including C+ and C-) may be applied to the program of study.
  - A course with a grade of C (including C+ and C-) may be repeated once, or a comparable course from another institution may be transferred in if this transfer does not exceed the allowed number of transfer credits.
- A successful oral examination (discourse) by the student, as evaluated by the student's committee, following completion of the portfolio and the majority of coursework, is required.

Students are encouraged to seek resolution of any academic issues (e.g., grades, withdrawal) that they may encounter during the course of their education.

The Graduate Nursing program acts vigilantly to resolve any issues on an informal basis. When issues arise, individuals are to first seek resolution at the lowest appropriate level. If resolution is not satisfactory, the individual informally escalates the concern, as appropriate, to the next level. Should issues not be resolved on an informal basis, the process for resolution becomes formalized.

The appeals process should occur in the following order:

#### Informal Process

- 1. The student will first discuss the academic issue with the faculty member of the relevant course.
- 2. If the matter remains unresolved, the student contacts the School of Nursing and Healthcare Leadership (SNHL) Chair in writing. The student provides as much detail about the academic issue as possible. The student and SNHL Nursing Chair will seek a potential resolution. If no resolution can be reached, the chair will direct the student in completing a written, formal appeal per University policy.

#### **Formal Process**

- 1. If the matter remains unresolved despite advancing the matter through the informal process ranks, the student will file a written appeal.

The School of Nursing and Healthcare Leadership (SNHL) at Minnesota State University Moorhead (MSUM) is committed to the promotion of quality education in an environment of civility, fairness, and integrity that is free from discrimination. To honor that commitment, students are encouraged to seek resolution of any concerns, problems, or grievances that they may encounter during the course of their education.

The SNHL acts vigilantly to resolve any issues on an informal basis. When issues arise, individuals are to first seek resolution at the lowest appropriate level. If resolution is not satisfactory, the individual informally escalates the concern, as appropriate, to the next level. Should issues not be resolved on an informal basis, the process for resolution becomes formalized.

A formal complaint is defined as a concern, grievance and/or complaint in which an individual feels they have not received treatment consistent with university policy and/or has concerns about SNHL students, faculty, staff, or the department as a whole. A complaint becomes formal after it cannot be resolved informally, at which time it is sent out in writing, and forwarded as outlined in the grievance/complaint sections of the MSUM Student Handbook.

The complaint process should occur in the following order:

### **Informal Process**

- 1. The student will first discuss the problem with the person(s) directly involved to seek resolution of the problem (for instance, another student, a preceptor).
- 2. If the matter remains unresolved, the student discusses the problem with the course faculty member.
- 3. If the matter remains unresolved, the student contacts the SNHL Chair in writing. The student provides as much detail about the concern as possible. The student and SNHL Chair indicate a potential resolution. If no resolution can be reached, the chair helps direct the student to complete a written, formal complaint and directs that formal complaint to the appropriate individual per university policy.

#### **Formal Process**

1. If the matter remains unresolved despite advancing the matter through the informal process ranks, the student will file a written complaint. The student should refer to the University Grievance and Complaint process in the MSUM Student Handbook when completing the formal complaint <a href="https://www.mnstate.edu/student-handbook/">https://www.mnstate.edu/student-handbook/</a>

All written formal complaints will be kept by the Dean of the college's discipline. Documentation of action/resolution in response to a formal complaint will be according to MSUM's Student Data Privacy procedures and the Master Agreement between Minnesota State and the IFO.
